## 1. Introduction

This work has been initiated to comply with item 11 of the Terms of Reference for the Sustainable Tourism Policy Development Consultant (STPDC):

“Develop a network of sustainable tourism web resources throughout the region and internationally and make available to CTO, CHA and individual national beneficiary states. Such resources shall include but will not be limited to contact addresses and links to various environmental organisations nationally, regionally and internationally; NGOs, private sector organisations; important websites, conferences, research, sources of funding, research and training institutions etc on sustainable tourism development”.

The task at hand is for the STPDC to bring together in one place, quality assessed internet resources on sustainable tourism that are deemed to be relevant to the Caribbean tourism sector. This requires the implementation of a desk-top review of information channels to build up a significant body of knowledge that can assist users of the *Regional Policy Framework for a more Sustainable Tourism Development in the Caribbean*.

By making this information available to various stakeholders at the national and regional levels, the intention is to provide policy makers and other key players in the tourism value chain, with a comprehensive guide to relevant internet resources when they are working with sustainable development issues.

## 2. Approach

Based on the above interpretation of the Terms of Reference, the STPDC proposes the following 4 step approach:

1. Trawl through relevant information channels to identify relevant web resources, of which the following are anticipated to be the main sources of information:
  - a. Final reports from 4 technical assistance consultancies launched within framework of CRSTDP Lot 3 Sustainable Tourism Policy;
  - b. CTO's resource library and intranet site;
  - c. The Internet, with particular use of the DestiNet Sustainable Tourism Information Portal, which has entered into cooperation with CTO/CRSTDP; and
  - d. Other relevant media channels including CTO's Annual Sustainable Tourism Conference and additional conferences, trade journals, email newsletters etc.
2. Organise the information into a matrix consisting of the six thematic areas put forward in the draft Regional Policy Framework for a more Sustainable Tourism Development in the Caribbean. This will provide user friendly accessibility to the information. It will also provide policy makers and other stakeholders with an interactive tool for use together with the Regional Policy Framework, as was proposed by the CTO Secretary General at a meeting with the STPDC and CTO counterpart in April 2007;

3. Recommend that the Caribbean tourism sector's intranetsite [www.onecaribbean.org](http://www.onecaribbean.org) is utilised to make this information available CTO, CHA and individual beneficiary states as required by the Terms of Reference, as well as international users;
4. Recognise that this is a dynamic tool that needs to be updated on a regular basis, in order to add new network web resources and check quality of links. This will be done by the STPDC during the course of the project, however, this can be facilitated over the internet in the future, so that users can suggest new links to web resources to CTO for upload, or report broken links.

### 3. Matrix

The suggested matrix format is presented below. The full matrix is presented in the following sections of this report. It's important to note that the resources are not listed in order of importance, but rather in the chronological order that they were recorded into the matrix.
